



## SERVICES PROVIDED

### RECOVERY SUPPORT

The Elijah Rising Transitional Program (ERTP) supports survivors in their recovery through a faith-based, 12-step model, emphasizing self-directed healing and long-term sobriety. Participants receive guidance, mentorship, and accountability through required recovery meetings, sponsorship, and a sober support network. Sobriety is mandatory, with regular drug screenings and medication monitoring to maintain a safe and structured environment. ERTP fosters resilience by providing resources, maintaining boundaries, and encouraging personal responsibility, ensuring participants transition successfully toward independent living.

### CASE MANAGEMENT

The Elijah Rising Transitional Program provides structured case management services to support residents continued growth into full independence. Each participant is assigned a Case Manager who conducts regular check-ins—weekly at intake, then semi-monthly and monthly—while also performing quarterly home checks to ensure compliance with community living guidelines. Employment is a key focus, requiring residents to secure a job or SSI benefits within 30 days, with ongoing job search assistance and work schedule review. Additionally, case managers guide residents in financial planning, maintaining government benefits, and accessing medical care, fostering long-term independence and stability.

## TECHNOLOGY POLICY

ERTP participants have access to house-provided WiFi, ensuring connectivity for work, education, and personal needs. While community areas remain free of shared computers and televisions, residents may purchase and use personal devices in their rented rooms. To maintain a respectful and structured environment, volume restrictions apply to all personal electronics.

## TOBACCO POLICY

ERTP residents may purchase tobacco products, but vaping is prohibited on the premises. Smoking is allowed only in designated areas to maintain a clean and respectful environment. In compliance with Texas Senate Bill 21, only residents 21 and older may use tobacco products, as the policy does not apply to those aged 18-20.

## COMMUNITY BENEFITS

ERTP fosters a supportive and engaging environment where residents continue to build meaningful connections. Mandatory Sunday evening house meetings ensure open communication and shared accountability. Residents are encouraged to organize dinner nights, strengthening community bonds. Participation levels are shaped collectively by housemates, allowing for a balanced and inclusive living experience.

# ERTP PROGRAM OVERVIEW

The Elijah Rising Transitional Program (ERTP) employs a faith-based, empowerment-focused, trauma-informed approach to assist adult (18+) female survivors of sexual exploitation as they transition toward independent living.

The program centers on stability, growth, and reintegration, offering a 6–24 month residential program designed to equip participants with the tools needed for sustainable independence.

Progress is attained through structured job support, financial literacy, community engagement, mentorship, life skills development, and recovery-informed support. Residents receive guidance in strengthening their professional skills, maintaining employment, and advancing in their careers.

Success is measured by progress toward self-sufficiency, emotional stability, strengthened social connections, and personal achievements, ensuring a well-rounded transition to independent living.

## CO-LIVING MODEL

Elijah Rising's transitional home operates on a co-living model designed to address the primary challenges survivors encounter after leaving a safe home. This approach provides affordable housing, a secure and supportive community, and financial sustainability, ensuring the model is self-sustaining and highly replicable for broader implementation and long-term impact.



## FAITH BASED APPROACH

Our organization is Christ-centered. We don't require you to be a Christian to be in our program. We do ask that while you are with us that you consider Christ and that you fully participate with an open mind.

## WHO QUALIFIES:

The Elijah Rising Transitional Program (ERTP) provides a structured path to stability for survivors of commercial sexual exploitation, focusing on recovery, employment, and independent living.

## ELIGIBILITY REQUIREMENTS

<b>Age &amp; Identity</b>	Adult, born biologically female and identifies as female
<b>Citizenship</b>	U.S. citizen or foreign national
<b>Background</b>	Survivor of commercial sexual exploitation
<b>Recovery</b>	Completed an anti-trafficking Restorative Care Program (60–90 days)
<b>Sobriety</b>	At least one year of continuous sobriety from alcohol and other substances
<b>Employment</b>	Must be employed or receive SSI benefits within the first 30 days
<b>Financial Readiness</b>	Ability to pay deposit, rent, and provide proof of income stability

This program equips residents with personalized case management, recovery support, and structured community living to foster long-term stability and independence.



## PROGRAM FEES & FINANCIAL STRUCTURE

**Application Fee:** \$160 total (\$60 non-refundable, \$100 refundable upon program completion).

**Agreement Deposit:** \$500 refundable upon move-out, based on unit condition and agreement fulfillment.

### Rent Structure:

6–12	\$550/month
12–18	\$650/month
18–24	\$700/month
<b>Month-to-Month Renewals</b>	Higher rates apply

**Renewals & Compliance:** Residents sign an initial six-month agreement with renewal options. Rent is due by the 5th, with a \$50 late fee thereafter. Ongoing financial responsibility is required to maintain program eligibility.
